In the reference cited 4th, the Government issued G.O vide G.O.(Ms) No.144, School Education (GE) Department dated 18.09.2014 making it mandatory for Schools affiliated to boards other than Secondary / Higher Secondary Boards of the State Government to get necessary recognition from the Director of School Education.

- (6) The school shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
- (7) The School shall not collect admission to any child,-
 - (a) For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
 - (b) On the ground of religion, caste or race, place of birth or any of them.

(8) The School shall ensure that,-

- No child admitted shall be held back in any class expelled from School till the completion of elementary education in a school.
